UPDATE: A federal judge vacated Brady's suspension, stating the NFL has no penalties for a player being "generally aware" of a violation [September 3, 2015]

UPDATE: McNally and Jastremski are reinstated by the NFL [September 16, 2015]

UPDATE: A 3-judge panel from the U.S. Second Circuit Court of Appeals reinstated Brady's suspension: "Our role is not to determine... whether Brady participated in a scheme to deflate footballs..." [April 25, 2016]

UPDATE: Brady and the NFL Players Association filed a petition for a rehearing before the full Second Circuit. A supporting brief was filed by 21 engineering and physics professors, claiming that deflation happens naturally when a closed vessel, such as a football, moves from a warm environment to a cold environment [May 23, 2016]

UPDATE: The full U.S. Second Circuit Court of Appeals refused to grant the petition for a rehearing, upholding the panel's ruling [July 13, 2016]

UPDATE: The Patriots beat the Atlanta Falcons in Super Bowl LI in OT 34-28, scoring 25 points in the 2nd after being down 28-9 at the half. It is the 5th title for both Brady and the franchise. Brady was named MVP for the 4th time [February 5, 2017]

UPDATE: Brady tells the media his Super Bowl jersey is missing and may have been stolen from the Patriots' locker room [February 6, 2017]

UPDATE: The FBI announces Brady's jersey as well as his Super Bowl XLIX jersey and other Super Bowl game-used items were recovered in Mexico. The suspect has been identified as Mauricio Ortega of *Diario La Prensa* [March 19, 2017]

UPDATE: The Philadelphia Eagles beat the Patriots 41–33 in Super Bowl LII [February 4, 2018]

UPDATE: The Patriots beat the Los Angeles Rams, 13–3 in Super Bowl LIII for its 6th Super Bowl title [February 3, 2019]

UPDATE: Brady announces that he has opted for free agency [March 17, 2020]

UPDATE: The Tampa Bay Buccaneers announce Brady has signed a 2 year deal for \$50 million, which includes \$9 million in incentives [March 20, 2020]

UPDATE: The Tampa Bay Buccaneers beat the Kansas City Chiefs 31-9 to win Super Bowl LV, Brady's 7th title [February 7, 2021]

UPDATE: The Buccaneers lose to the Los Angeles Rams 30-27 in the NFC Divisional Playoffs as Brady is slapped with an unsportsmanlike conduct penalty [January 23, 2022]

UPDATE: Brady announces his retirement, two days after his father told the media that his son was not retiring [February 1, 2022]

UPDATE: Brady announces he will play for the Buccaneers next season after 40 days into his "retirement" [March 13, 2022]

UPDATE: Bündchen's petition for divorce is granted 3 days after she and Brady entered into an MSA with neither "filing any of their financial disclosures with the Court" [October 28, 2022]

UPDATE: The Buccaneers lose to the Dallas Cowboys in the NFC Divisional Playoffs 31-14, the first loss to Dallas in Brady's career [January 16, 2023]

UPDATE: One year to the day after he announced his retirement, Brady announces his retirement again "for good" [February 1, 2023]
