When I lived in Boston in the 1980's, there was a homosexual couple in my building. I asked them once if they ever want to get married. Oh, no, they replied, marriage represented everything their coupling stood against: societal conformity and repression.

As even microbes on Mars know, things have changed.

Of the 37 states which had "marriage equality" before June 2015, only three states voted for it; Minnesota voters rejected a marriage amendment, making "marriage equality" *de facto* law. Four states had "marriage equality" imposed by their supreme courts. Eight states had "marriage equality" imposed by legislation. California had "marriage equality" imposed on it when the United States Supreme Court dismissed an appeal of a federal ruling nullifying the passage of Proposition 8 by voters.

There are three main arguments for "marriage equality":

- a) marriage is a right
- b) it poses no threat to religious freedom
- c) some people are born non-heterosexual

The first canard is based on the Equal Protection Clause of the 14th Amendment. The Clause was born of The Civil Rights Act of 1866, based on the Due Process Clause of the 5th Amendment. "Due Process" refers to judicial proceedings ONLY. Homosexual conduct was illegal in every state when the 14th was ratified. The idea that its authors crafted it so that homosexuality and "marriage equality" would someday be legitimated by a future Supreme Court is not only baseless, it is beyond ludicrous!

Not so ludicrous is the second canard. For immorality in all of its forms – including pedophilia and pederasty - to be accepted, those who object must be discredited and destroyed, which is why Public Enemy #1 for LGBTQQIAPK activists and their allies is religion. To cite just a few of way too-many examples:

* The rainbow flag, the symbol of LGBTQQIAPK "liberation", was designed to mock God's covenant with Noah.

* FCKH8.com videos blame Christians for suicides by teens in turmoil over their gender and/or sexual identity.

* Films/TV shows portray people of faith as haters, bigots, and/or repressed homosexuals.

* Jesus has been portrayed as a homosexual, a pedophile, and a transgender.

- * A Muslim man was arrested for kicking two men out of his cab for kissing.
- * The Southern Poverty Law Center won a lawsuit against Jews Offering Healthy Alternatives to Homosexuality (JONAH) for "fraud". During the discovery phase, the judge, in barring its experts from testifying, declared JONAH an "outlier".
- * The Christian chief of the Atlanta, Georgia Fire Department was fired because he called homosexuality a "perversion" in a self-published book.
- * Five pastors who sued the lesbian mayor of Houston, Texas after her administration blocked a petition to repeal an LGBTQIAPK ordinance were ordered to turn over e-mails and sermons critical of the ordinance, homosexuality, same-sex marriage or the mayor.
- * A Christian-owned Gresham, Oregon bakery was forced to close after the owners refused to bake a wedding cake for a lesbian customer; the state imposed a \$135,000 fine.
- * A&E suspended the Christian star of its reality show *"Duck Dynasty"* after he gave an interview endorsing the Biblical view of marriage and homosexuality.
- * The mayor of Salem, Massachusetts canceled the city's contract with Gordon College to manage Salem's Old Town Hall over the college's policy forbidding students and faculty from pre-marital sex, adultery, and homosexual activity.
- * A chaplain was dismissed by the Navy Special Warfare command after counseling students that pre-marital sex, adultery, and homosexuality are contrary to Biblical teachings.
- * The White House and several state capitol buildings were lit up as a rainbow flag to celebrate the Supreme Court's "marriage equality" opinion.

The third canard is the crux of the LGBTQIAPK (Lesbian, Gay, Bisexual, Transgender, Queer, Intersexual, Asexual, Pansexual and Polygamous, and Kinkiness) movement, which was inadvertently exposed as the sham it is at the 2015 Oscars. *Queerty* had to run a correction after it called Best Adapted Screenplay winner Graham Moore a "queen" and his acceptance speech the event's "gayest and greatest moment" after he told reporters that he doesn't identify as gay. Commenting on *Queerty*'s "our bad", *The Atlantic* refused to acknowledge the irony of *Queerty*, founded for the purpose of refuting stereotypes, pegging Moore as homosexual based on stereotypes; instead, it blamed Moore for conflating "gay" and "straight" identities in his speech!

As if to prove they are equal-opportunity haters, LGBTQIAPK activists ripped actress Cynthia Nixon for telling the New York Times that she is gay by choice, and openly-gay actor

Rupert Everett for telling the *Sunday Times* that a child needs a mother and a father. Activists launched a boycott against openly-gay hoteliers Ian Reisner and Mati Weiderpass after they hosted a reception for "anti-gay" Ted Cruz. Openly-gay fashion designers Domenico Dolce and Stefano Gabbana incurred the wrath of activists for publicly stating their opposition to surrogacy, same-sex adoption, in vitro fertilization, and "marriage equality". To their credit, Dolce and Gabbana, unlike Reisner and Weiderpass, neither backed down or apologized.

But wait! There's more! MUCH more:

- * General Mills opposed the Minnesota Marriage Amendment.

- * Crate & Barrel, Target, Macy's, and The Gap have opened same-sex wedding registries.

- * Aetna, Bristol-Myers Squibb, eBay, Electronic Arts, and Marriott joined the Human Rights Campaign's effort against the Defense of Marriage Act (DOMA).

- * JP Morgan Chase surveyed employees about their sexual identity and if they are "an ally of the LGBT community".

- * Intel, Lockheed, Disney, and UPS ended its sponsorship of the Boy Scouts -- even after it agreed to allow boys who identify as homosexual to join.

- * Below are other American companies which contribute to LGBTQIAPK groups, sponsor LGBTQIAPK events, run LGBTQIAPK ads, support LGBTQIAPK legislation, and implement pro-LGBTQIAPK policies in the workplace, despite the fact that the vast majority of them do business in countries with anti-LGBTQIAPK laws:

That's for starters:

- * After the Supreme Court used the Due Process Clause of the 5th Amendment to strike down DOMA, a July 2013 cover of The New Yorker depicted Bert and Ernie of Sesame Street cuddling before a TV image of the Justices.
- * Chick Fil-A ended donations to anti-"marriage equality" groups after thousands rallied to support the fast-food chain when LGBTQQIAPK groups called for a boycott due to the CEO's anti-"marriage equality" stance.
- * ABC, Bloomberg, CBS, CNN, Comcast, Cox Media, Crain, Fox, Gannet, Hearst, and McClatchy sponsor the National Lesbian and Gay Journalist Association.
- * Sponsors withdrew from Boston's 2014 St. Patrick's Day Parade when organizers refused to allow LGBTQQIAPK groups to march. Boston's Gay Pride Parade "reserves the right to deny participation and/or registration of any group or individual who may be considered unacceptable to participate by the community".
- * New York's 2015 St. Patrick's Day Parade featured an LGBTQQIAPK group with the approval of Grand Marshal Cardinal Timothy Dolan.
- * A federal judge ruled parents with children in Massachusetts public schools have no right to be notified when LGBTQQIAPK subjects are taught.
- * It is illegal in California and New Jersey for parents to seek therapy for their child struggling with same-sex attraction and/or gender identity.
- * People born in the District of Columbia may obtain birth certificates with their preferred gender-designation.
- * Public schools in California must allow students who identify as the opposite gender access to gender-based programs and facilities.
- * Pressured by corporations and fellow Republicans, Arizona governor Jan Brewer vetoed SB 1062, which would have allowed businesses to cite faith as a defense if sued by a same-sex couple. The NFL threatened to relocate Super Bowl XLIX if SB 1062 became law.
- * The all-women Mills College and Mount Holyoke College allows men who identify as female and women who identify as male to apply for admission.
- * The University of Vermont allows students to select their gender identity.

- * The Girl Scouts announced boys who are "recognized by the family and school/community as a girl and lives culturally as a girl" will be allowed to join.
- * A federal judge ruled Eastern Michigan University was justified in removing a student from a counseling program because she believes homosexuality is immoral.
- * A Lexington, Kentucky merchant was ordered to undergo "sensitivity training" for refusing to print t-shirts for a gay pride festival.
- * Beth Israel Hospital fired a urologist for warning patients about the risks associated with homosexual activity.
- * The American Medical Association endorses "marriage equality", same-sex adoption, and ending the ban on blood and tissue donation by gay and bisexual men.

So how does it affect you if Adam and Steve take the plunge? As marriage touches on nearly every facet of the law, it affects you plenty:

- * A Pennsylvania man adopted his boyfriend to avoid inheritance tax. Another man who adopted his boyfriend is suing Pennsylvania for the "right" to "marry" him.
- * A Florida judge approved a birth certificate naming a lesbian couple and a gay man the "parents" of a baby.
- * North Dakota's Attorney General determined that a man who wanted to marry a woman in North Dakota could do so without having to divorce his "husband".
- * A federal judge decriminalized polygamy in Utah. Congress denied Utah statehood until the Church of Jesus Christ of Latter-Day Saints abolished polygamy.
- * The Tennessee Department of Health allowed a woman to be named the "father" of a baby born to her "wife".
- * Pressured by his employees, Mozilla co-founder Brendan Eich resigned after it was learned he donated \$1,000 in support of Proposition 8.
- * A Marquette University professor was fired after criticizing a teaching assistant's refusal to allow a student to speak against same-sex marriage.
- * The Arizona State Court of Appeals granted a woman who lives as a man permission to divorce "his" "wife".

* The New York State Court of Appeals ruled an uncle-niece "marriage" valid. In 1921, the same court found that exact union invalid.

So how did we go from homosexuals rejecting marriage to a president giving it his okay? Birth control. Women's liberation. Abortion on demand. Sperm banks. Surrogacy. No-fault divorce. Acceptance of pre-marital sex and illegitimacy. Widening socioeconomic gap. A debased culture. An apathetic and dumbed-down citizenry. All these can be traced to two crackpots: Robert Owen (1771–1858), and John Humphrey Noyes (1811–1886).

On July 4, 1826 - the 50th anniversary of the signing of the Declaration of Independence, and the day John Adams and Thomas Jefferson died - Owen issued an Oration Containing a Declaration of Mental Independence as he dedicated the establishment of his socialist utopia paradise, New Harmony, Indiana. Asserting that the Declaration of Independence "prepared the way to secure you mental liberty", he continued: "... Man... has been, in all parts of the earth, a slave to a trinity of the most monstrous evils that could be combined to inflict mental and physical evil upon his whole race. I refer to private property, absurd and irrational systems of religion and marriage founded upon individual property, combined with some of these irrational systems of religion."

Convinced the second coming of Christ occurred in 70 AD, Noyes concluded that, unless man was truly free of sin, then Christianity was a lie, and that only those who were perfect and free of sin were true Christians. Further, because he surrendered his will to God, he maintained everything he did was perfect because his choices "came from a perfect heart". His commune in Oneida, New York was dedicated to what he coined "free love": collective sex, collective parenting, collective property, collective exchanges of God-know-what. But his true legacy is what we now call eugenics: 53 women and 38 men - matched for their spiritual and moral qualities (!) - participated in the quest to breed "perfect" children -- 9 of them fathered by Noyes himself.

Owen nor Noyes would have dared to agitate for LGBTQQIAPK "rights", much less, "marriage equality". Yet each would have recognized both as the perfect vehicles to obliterate religion, property rights, the family unit, and marriage itself. No doubt, they would have been jolly-well pleased with the New York Gay Activist Alliance's shakedown of the American Psychiatric Association to remove homosexuality from its list of mental disorders. Not 10 years after *TIME* declared the homosexual "needs no glamorization, no rationalization, no fake status" (1/21/1966), it put Air Force Sgt. Leonard Matlovich on its cover with the heading "I Am a Homosexual" (9/8/1975). The Matlovich story came 10 years after psychologist George Weinberg coined the word "homophobia", meaning "an irrational fear of loving someone of the same sex"; it has since been used to mean a fear of homosexuals and homosexuality. Activists realized early they weren't going to get anywhere unless they hijack both the language and the civil rights movement, so the public would be duped into equating

those who practice homosexuality and/or its myriad off-shoots as a separate class of individuals ("born that way"). As to why schoolkids are now taught that "male" and "female" are social constructs look now further than Johns Hopkins University psychologist and truly-sick bastard John Money (1921-2006).

Money, who coined the terms "gender identity" and "sexual orientation", was approached in 1967 for help by the parents of infant Bruce Reimer. Bruce and his twin brother Brian suffered from phimosis; a botched circumcision left Bruce's penis damaged beyond repair. At Money's urging, Bruce underwent an orchiectomy, given hormones, and raised female, however, the parents rejected his recommendation to have their toddler undergo a procedure to create an artificial vagina. As Money crowed over the years of the "success" of Bruce's case ("proof" that gender identity is a "learned behavior"), he forced Bruce and Brian to simulate sex acts, and strip naked for "genital inspections". When Bruce was 14, his parents finally told him the truth. He chose to call himself "David", and have his "breasts" removed. Brian became a schizophrenic, and committed suicide in 2002. David committed suicide in 2004.

It probably won't come as a surprise to learn that Money was rah-rah for pederasty, declared pedophilia was the end-result of a surplus of parental love turning erotic (!), that and heterosexuality is a superficial, societal concept.

With the outbreak of AIDS and the murder of college student Matthew Sheppard, activists pushed the narrative gays and AIDS victims (including Matlovich) were not victims of their own choices, but "martyrs" of "hate", again, hijacking the language. The tactic worked to such perfection when Stephen Jimenez, who identifies as homosexual, revealed in his biography of Sheppard that he was a child predator who was victimized as a child, and was murdered over a drug deal gone bad, he was shunned by the mainstream media.

Cut to May 9, 2012: Obama endorses "marriage equality", telling ABC News "it doesn't make sense" to his daughters that "their friends' [gay] parents would be treated differently". His Machiavellian set-up to throw his own children under the bus for political expediency was of no concern to the media praising him for his "evolvment".

Just how in the tank is the media for the LGBTQQIAPK movement? Did you read that Terry Bean, co-founder of the Human Rights Campaign and top Obama bundler, was arrested on charges of assaulting a 15-year old boy? Or that the HRC owes its existence to a smut-peddler named Chuck Holmes, who died of AIDS? Or that Obama admitted to YouTube personality GloZell that being LGBTQQIAPK is "a lifestyle choice"? No, you did not.

Try as activists may to portray the LGBTQQIAPK lifestyle as idyllic, even preferable to heterosexuality, the facts state otherwise:

* The National Coalition of Anti-Violence Programs recorded 2,679 reports of same-sex domestic violence in 2012, a 29.6% increase from 2011.

* A 2010 National Intimate Partner and Sexual Violence Survey found 67.4% of lesbians reported abuse by a partner; 90.7% of gay men reported abuse by a partner.

* A 2010 survey by the Gay & Lesbian Medical Association found homosexuals suffer higher rates of depression and substance abuse than heterosexuals.

* A 2010 survey by the National Gay and Lesbian Task Force found that 41% of the 7,000 "transgenders" surveyed had attempted suicide.

* The CDC reports that gay and bisexual men account for 83% of of primary and secondary syphilis cases reported in 2014. 51% of the gay and bisexual men diagnosed with syphilis were also HIV-positive.

On June 26, 2013, the Supreme Court ruled DOMA unconstitutional and returned Proposition 8 to the 9th Circuit. As Obama and Attorney General Eric Holder hailed the disenfranchisement of California voters, governor Jerry Brown ordered clerks to issue marriage licenses to same-sex couples.

The 6/28/2013 Los Angeles Times spun Brown's refusal to defend Proposition 8 by noting his father, Edmund, governor from 1959-1967, refused to defend Proposition 14 (1964) which nullified the Rumford Fair Housing Act. But there is a BIG difference: those who sued to overturn Proposition 14 could show harm; those who sued to overturn Proposition 8 could not. Incredibly, a 9/7/2010 Times op-ed lectured Brown and then-governor Arnold Schwarzenegger on their "obligation to defend the laws of the state, whether they like them or not. And that should include the ban on same-sex marriage".

The opinion by Justice Anthony Kennedy that DOMA sought to "injure" homosexuals was not only baseless, it flies in the face of *McCray v. United States* (1904):

"The decisions of this court from the beginning lend no support whatever to the assumption that the judiciary may restrain the exercise of lawful power on the assumption that a wrongful purpose or motive has caused the power to be exerted".

Translation: *Windsor* is unconstitutional!

With *Windsor*, Kennedy not only placed the government at the disposal of activists - whose bullying of politicians, celebrities, corporations, journalists, jurists, and educators into apathy and cowardice has succeeded beyond their wildest dreams - more frightening, he gave the IRS the power to revoke the non-profit status of organizations which refuse to tow the line!

On April 28, 2015, the Court heard arguments on *Obergefell v. Hodges*:

Does the 14th require a state to license a marriage between two people of the same sex?

Does the 14th require a state to recognize a marriage between two people of the same sex when their marriage was lawfully licensed and performed out-of-state?

The answer to both is NO for two reasons:

* As stated, the 14th pertains to judicial proceedings ONLY: life (self explanatory), liberty (physical movement), and property (personal possessions) cannot be taken from a citizen except by a jury of his peers at a fair trial.

* Article I, Article III, and Article V DENIES THE JUDICIARY THE AUTHORITY TO REDEFINE MARRIAGE!

Instead of pointing out the obvious, "our side" sounded like a bunch of whiny defeatists, wanting desperately not to be painted with the Bigot Brush. John J. Bursch - whose law firm, Warner, Norcross & Judd, refused to support him (NO major law firm was willing to submit an *amicus* in favor of traditional marriage) - gets my vote for the most-cowardly and incompetent "argument". In other words, the fix was in.

On June 26th, to no one's surprise, Kennedy, joined by Justices Breyer, Ginsberg (who officiated a "gay wedding"), Kagan (who also officiated a "gay wedding"), and Sotomayor "found" the 14th Amendment "guarantees" a "right" to "marriage equality", and, because it "does", current marriage laws "discriminate" against same-sex couples.

How did Kennedy get away with nullifying the will of 51 million Americans? Why won't governors and attorney generals tell him where to stick his blatantly-unconstitutional opinion? Why won't Congress impeach and remove his arrogant ass? For the same reason why the Court got away with ordering the sterilization of a Virginia woman for "feeble-mindedness" (*Buck v. Bell*); got away with decreeing that prayer in public schools was unconstitutional (*Engel v. Vitale*); got away with decreeing contraception (*Griswold v. Connecticut*), abortion (*Roe v. Wade*), and consensual sodomy (*Lawrence v. Texas*) are constitutional "rights": *Marbury v. Madison*, in which the Court created the conceit of "judicial review". Because of *Marbury*, the public believes the Court's word is "the law of the land".

Since when did We the People grant the judiciary the power to determine and define our rights? If I had a dime for every time I have heard the talking airheads screech that *Obergefell* is now "the law of the land", I'd make Bill Gates look like a damn pauper!

In upholding the federal law banning polygamy in the Utah territory (*Murphy v. Ramsey*), the Court stated:

"For certainly no legislation can be supposed more wholesome and necessary in the founding of a free, self-governing commonwealth, fit to take rank as one of the coordinate states of the Union, than that which seeks to establish it on the basis of the idea of the family, as consisting in and springing from the union for life of one man and one woman in the holy estate of matrimony; the sure foundation of all that is stable and noble in our civilization; the best guarantee of that reverent morality which is the source of all beneficent progress in social and political improvement".

The Court understood the upheaval which would have ensued had it recognized polygamy. Kennedy, Breyer, Ginsberg, Kagan, Sotomayor (and Obama) have given America a big push toward the abyss. If history has taught us one lesson, it is that EVERY civilization which has rejected Natural Law in the high-holy names of "progress" and "evolution" has collapsed. The Founding Fathers are spinning in their graves.

UPDATE: Justice Antonin Scalia died and suddenly the Left cares about the Constitution, and how dare Republicans vow to keep Obama from fulfilling "my constitutional responsibilities" (selling guns to Mexican drug lords is one of your "constitutional responsibilities"?), and tap a replacement. Pundits parroted how Scalia was "a leader of a conservative intellectual renaissance" (*New York Times*). He was anything but: he allowed judges to strike down "marriage equality" bans AND dismissed the appeal of the ruling nullifying Proposition 8! Incredibly, Kennedy sided with the appeal. [February 13, 2016]

UPDATE: Neil Gorsuch was sworn in as Associate Justice of the Court to replace Scalia. Good News: Gorsuch is an originalist (or so he claims). Bad News: Gorsuch attends a pro-LGBTQ / gun control / climate change church, and clerked for Kennedy. Something tells me Goober will do as his mentor wants. [April 10, 2017]

UPDATE: Kennedy announced his retirement, effective July 31st. [June 27, 2018]

UPDATE: Brett Kavanaugh was sworn in as Associate Justice of the Court to replace Kennedy after a contentious Senate Judicial Committee hearing in which he was accused by a woman of sexual assault while they were in high school. Like Gorsuch, Kavanaugh clerked for Kennedy and claims to be an originalist. [October 6, 2018]
